



Request for a legislative Lone Star Shield: Implement funding and legislation for establishment of an oversight committee to protect Texans from unconstitutional international and federal laws.

The following outlines the information distributed from Texas Right To Know (TRTK) to the public, Texas Legislators and agencies showing, **“What we knew, when we knew it, and why all need to know it now.”**

1. 2020, April 2 – [PRNewswire](#) - **“Texas Right to Know Calls on US to Consider COVID-19 Ozone Therapy After It Shows Promise in Italy,”** showing [negative test swabs in 5 days](#). [Ozone](#) treats viruses, like [Marburg](#), [Ebola](#) etc.
2. 2020, June - TRTK submits [request to TMB](#) to change Physician [Violation Guidelines rule 190.A](#), - [PRNewswire](#) - **“Texas Medical Board Clarifies Access To Ozone Therapy for the Treatment of COVID-19.”**
3. 2020, July 31, TMB issues press release [TMB clarifies doctors can treat COVID-19](#) under [CAM rules](#).
4. 2020, July -TRTK collates [forty+ reports of ozone effectiveness](#) received from around the world, such as [Italy](#), [Spain](#), and Wuhan Hospital. Assembled medical team w/ FL Larkin Hosp. to pursue FDA approval for ozone.
5. 2021 – Jan – May Texas Legislative session – TRTK provides weekly [testimony](#) at hearings, committee staff meetings, and legislator meetings, etc. warning of blood clots, conveying results of medical studies, etc.
6. 2021, March 10 - Sheila Hemphill gives [March 10, 2021 - WARNING Testimony](#) at Texas Senate HHS Committee regarding SARS-CoV-2 containing sequences of HIV, PRRA, and prion-like structures resulting in [Creutzfeldt-Jacob aka human “Mad Cow”](#) from exposure to the virus [spike protein itself](#) – not just from [mRNA drugs](#), see [May 2022 report](#), and delivers the document **“Death by Government Policy”** showing how the CDC and NIH prohibited therapeutics being approved in order to comply with the [PREP Act](#) [EUA criteria](#) requiring that **“there are no adequate, approved or available alternative to the product.”** See pg 3.
7. TRTK develops and delivers to legislators and staff graphic posters depicting function and visual aspects while asking **“Is SARS-Cov-2 a Bioweapon?”** Posters show associated links to studies and reports from the [Vaccine Adverse Events Reporting System](#) (VAERS). The poster’s question is answered on March 11, 2020 in FOIA release of Anthony Fauci’s email, subject line **“Coronavirus Bioweapon Production Method,”** pg. 2286.
8. 2021 – August - TRTK distributes to every office of all Texas legislators and other Texas government officials the 77-page report, [The Omega Brief](#), based on the research of Dr. David Martin’s [July 11, 2021 interview](#) with Reiner Fuellmich showing NIAID, NIH board meeting minutes, intentions, and patent ownership of SARS, **“We made SARS and patented it on April 19, 2002, ... funded by Anthony Fauci in 1999 ... to target human lung epithelium - with an infectious, replication defective, coronavirus.”** Patent # [7279327](#).
9. 2021, August 19 - [PRNewswire](#) - **“Texas State Elected Officials Received Notice of Pandemic Criminal Conspiracy and Racketeering”**, showing irrefutable evidence contained in patents delivered to officials.
10. 2021 – October 6-current - TRTK serves as a whistle blower to the Texas legislators and other government officials in Austin about the "Trojan horse" in the [SB 8 Coronavirus recovery funds](#) and CARES Relief Funds that **jeopardize the sovereignty of every city/county/business who signs the US Treasury contracts and makes the recipients subservient to federal executive orders by consent of contract.** [TML misleads cities.](#)
11. 2021 – October 27, [PRNewswire](#) - **“Will Governor Abbott Save Texas From Transfer Of Sovereignty By Contract?”** October 15, AG Paxton sends [letter](#) to agencies warning of compliance with federal regulations.
12. 2021, November 8, Governor Abbott signs SB 8 with [filing statement](#), then on December 14 – [Governor Abbott Instructs State Agency Leaders To Review New Federal Funding Agreements, Contracts.](#)
13. 2022, June 27 – Senate HHS hearing, TRTK delivers testimony and following posters graphically depicting and linking to studies showing that [SARS-CoV-2 is a bioweapon](#), [blood clots](#) being reported from embalmers, and [DNA being altered](#) from the [mRNA operating system](#) aka “COVID-19 Vaccines.” [SCOTUS ruling on DNA patents.](#)
14. 2022, June 28 – Senate Finance Committee, TRTK warns of Marburg – July 7, [WHO announces Marburg outbreak in Ghana](#).
