



**We will never heal mental illnesses until physical root causes such as: food allergies, food dyes, fragrances, mold, parasites, bacterial, and viral infections, drug side effects, heavy metals and chemical toxins, electro-magnetic fields (EMF), vitamin and nutritional deficiencies, and “immune paralysis” are ruled out.**

These are a few of the physical root causes documented in medical literature to manifest as psychiatric dysfunction. Medical physicians are not trained to explore for physical root causes when the patient exhibits behavioral problems since they are trained to forward those patients for behavioral and/or psychiatric evaluation.

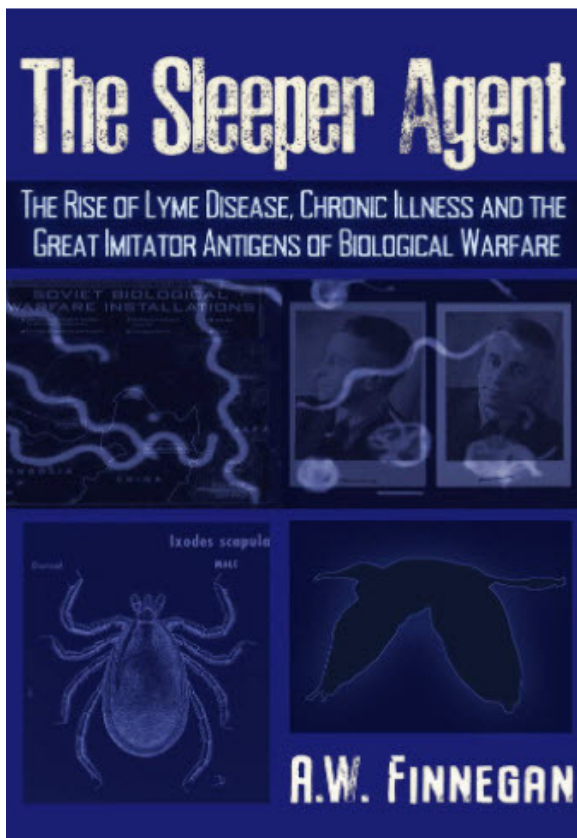
With “evidence based medicine”, a physician forms a hypothesis based upon a patient’s condition and the patient’s complaints. Using the International Classification of Diseases (ICD 10 Codes), the physician often orders various bloodwork, tests, or scans to substantiate their hypothesis in order to perform procedures for treatment using Current Procedural Terminology (CPT) codes for billing. If the tests come back, “negative or normal”, the physician risks being accused of fraudulent billing if the documentation from the tests does not support their billable treatments. Despite the patient’s reports of debilitating conditions, the physician often deems these reported complaints as being psycho-somatic aka “all in their head” and the patients may be dismissed with no assistance, or given a referral for a behavioral / psychiatric evaluation for treatment with psychiatric drugs, or placed in psychiatric facilities with a common \$1,000 per day fee.

Now with the recent publication of the book, “The Sleeper Agent: The Rise of Lyme Disease, Chronic Illness and the Great imitator Antigens of Biological Warfare”, which shows the medical research behind the term “immune paralysis aka immune tolerance” is now documented.

**Immune paralysis is the body's inability to invoke an immune response, being unable to produce antibodies, a fever, or inflammation markers, etc. despite the fact that their body is in a state of debilitating, chronic infection. Current medical studies show a potential correlation between the COVID-19 vaccine and Vaccine Acquired Immune Deficiencies (VAIDS).**

The mechanism behind “immune paralysis” was identified as Lymphocytic Choremeningitis (LCM) in 1933 by Dr. Erich Traub at the Rockefeller Institute. Dr. Traub was known as the premier bioweapon scientist during WWII until his death until 1985. The early studies demonstrated that devious infection can be present, actively causing a chronic, slow disease while the patient appears healthy with no abnormal bloodwork, little to no antibodies or inflammation but leaves the victim feeling horrible, incapacitated, and experiencing debilitating neurological and psychological conditions.

In the simplest of terms, the term “immune tolerance” can be thought of as chronic immunosuppression, an impaired immune system that leaves the individual sick and worn out. The early studies of immune tolerance and LCM virus by Erich Traub taught us that a devious infection can be present, actively causing a chronic, slow disease while appearing healthy with no abnormal bloodwork, little to no antibodies or inflammation, but left the victim feeling horrible and incapacitated, and this is where the dynamic began to turn in favor of stealth disablers that destroy the immune system as effective weapons in a long-term strategy.<sup>5</sup> It was a disease marked by slow, chronic health problems and invasion of the central nervous system. Particularly noteworthy is Traub’s 1960 paper, “Observations on immunological tolerance and ‘Immunity’ in mice infected congenitally with the virus of lymphocytic choriomeningitis (LCM),” because it is here we find some of the best descriptions of the stealth mechanisms that underlie many of the controversial chronic diseases plaguing Americans today, with patients who are very ill with some of the most debilitating symptoms yet their healthcare providers are finding no signs of illness, no antibodies to disease agents, and no abnormal bloodwork, and based on this, they deny the complaints of their patients as illegitimate or psycho-somatic:

Mice infected [congenitally from mother to newborn] with LCM virus carry large amounts of active virus in their blood and organs for many months and discharge considerable quantities of the agent with their secretions and excretions (11). This observation indicates continuous multiplication of the virus in the organs of such animals, which look like normal individuals in spite of their chronic infection. [Maternal transmission of LCM] infection leads to a stable [parasitism] between virus and body. It was also observed that mice infected [in the womb] would develop practically no [LCM Virus] antibodies.

[...] Attempts to demonstrate neutralizing antibodies in the [blood] of such animals using customary techniques gave essentially negative results.<sup>103</sup>
